



HOW TO ACCESS YOUR 1098-T FORM



Log into your [MyHusky](#) student account.

From your dashboard, select **Finances** and in the drop down box select **View 1098-T**.

If you have not already granted permission to receive your 1098-T Form online, a screen will appear for you to **Grant Consent**.



If you have not granted consent for on-line access to your 1098-T the above screen will appear. Click on **Grant Consent** and follow the instructions on the 1098-T Consent screen.

I agree to receive my 1098-T Tax form electronically through on-line access. Clicking the 'Yes, I have read the agreement' checkbox means you will no longer receive the 1098-T form via US mail. Click the Submit push button to always access your 1098-T on-line.
