Housing/Food Service Agreement

TERMS AND CONDITIONS

Revised: October 2023

Commonwealth University - Bloomsburg agrees, when spaces are available, to assign on-campus residence hall, suite or apartment accommodations to students who are eligible to live on campus. Upon execution of the agreement, the student agrees to abide by all university and residence hall/suite/apartment rules and regulations as set forth below and in the Guide to Campus Living and other university publications. The university houses students without regard to race, creed, age, sexual orientation or disability in compliance with state and federal legislation.

I. ELIGIBILITY

2- year residency requirement: All full-time undergraduate students are required to live on campus for their first four semesters (not including summer and winter sessions) unless they turn 21 years of age before the first day of classes for the fall semester or are commuting from the home of their parent(s) or legal guardian(s) within 50 miles of campus.

As part of the 2-year residency requirement, students will complete a new housing agreement for the following year and will have the opportunity to select their specific housing location during the housing selection for returning students process. Information will be sent to all on-campus residents beginning in late September or early October with the room/suite/apartment selection process occurring later in the fall or early spring semester.

Students under obligation of the 2-year residency requirement who do not complete this process and select housing or do not have an approved exemption will automatically be matched with roommates and assigned housing by the Office of Housing & Residence Life.

Students wishing to request an exemption must submit the 2-Year Residency Requirement Exemption Request. The form is found online at <u>Forms and Policies</u>. **You will not be exempt** unless you receive an approval notice from the Office of Housing & Residence Life.

Full-time matriculating students currently living on campus are eligible to continue living on campus. A full-time student is enrolled for 12 or more credit hours per semester. Falling below 12 credits during the semester is not grounds for breaking your housing agreement.

Commuting students or students who have moved off campus who wish to live on-campus, must contact the Office of Housing & Residence Life for availability.

The University does not provide housing for married students with their spouses or for students with children or dependents.

PA state law requires all students residing in campus owned facilities must either have received the meningitis vaccine or agree to a waiver based on information concerning the benefits of the vaccine. More information regarding meningitis can be found at Meningitis Vaccine.

II. HOUSING POLICY FOR DISCIPLINE AND JUSTICE INVOLVED STUDENTS

Policy Statement: Commonwealth University - Bloomsburg strives to provide a safe campus and learning environment. As a part of that effort, when the Office of Housing & Residence Life receives an application for on-campus housing from an individual who has been convicted of certain criminal offenses and/or received a disciplinary sanction from an institution of higher education, the application will be forwarded to the Discipline/Justice Review Committee.

A conviction or disciplinary action does not, in and of itself, disqualify an applicant from residential

housing. The Committee's task is to evaluate the nature and extent of the applicant's potential threat to campus safety and the University's learning environment based on considerations of the nature and age of the offense, its severity and the relation of offense or disciplinary action to campus housing.

The Committee will review the completed documentation and determine if the applicant is eligible for residential housing. As part of this process, the University may request additional documentation from the applicant and may, where appropriate, request that the applicant appear for an interview with the Committee. The Committee's decision is final.

If the relevant requested documentation is not received from the applicant, the application will remain incomplete. Should the requested documentation not be received within 2 weeks of the document request date, the Office of Residence Life has the option to cancel the application as incomplete.

If an applicant answers no to the criminal background or the disciplinary history application question(s) and it is later found the applicant did not truthfully respond to the questionnaire or provide complete and truthful information, the University has the right to rescind the offer of residential housing or take disciplinary action that may include removal from housing and/or dismissal from the University.

Reason for Policy: This policy has been established to provide consistent and equitable decisions regarding access to residential housing for those individuals with prior involvement with justice or student conduct actions.

Definitions:

- 1. Criminal Conduct refers to a felony or misdemeanor conviction. A conviction is an adjudication of guilt, including pleas of nolo contendere (no contest). For purposes of this definition, convictions for traffic citations, summary offenses, or which have been expunged or sealed are not considered. This term also specifically excludes an adjudication of delinquency for a criminal offense.
- 2. Disciplinary Action refers to a disciplinary sanction of removal from housing, suspension, expulsion or other form of dismissal from an institution of higher education for behavioral misconduct. For purposes of this definition, interim measures (e.g., interim suspensions, interim housing removal, etc.) are not considered. Pending initiation of student conduct charges is not considered unless the student withdraws or has withdrawn prior to disposition of the charges.
- 3. Enforcement Body: Discipline and Justice Involved Students Review Committee

III. AGREEMENT TERMS

The Spring Housing/Food Service Agreement is binding for the period of the spring semester, (or remaining portion thereof) and may not be transferred, reassigned or sublet. Housing/food service fees do not cover vacation periods when the university is officially closed. Students withdrawing from the university must vacate their room/suite/apartment within 48 hours.

Students can request to be released from their housing agreement if they provide proof of marriage during the period of the agreement or if a student is required to live elsewhere to complete their academic program (internship, student teach, co-op, December graduates).

Students who wish to cancel their Housing/Food Service Agreement must submit a housing release request. You are not released until you receive an approval response from the Office of Housing & Residence Life. A housing cancellation fee may be applied depending on when you submit the request and your reason for requesting to be released.

Students needing continuous 12-month housing to cover the inter-sessions or who anticipate taking an on-campus Winter Session course (time between fall and spring semesters) must be assigned to a Montgomery Place, Mt Olympus, or Jessica Kozloff Apartment, Soltz Hall, or the designated 12-

month residence hall. Students need to be aware that staff and services are limited during intersessions. Students staying over inter-session must submit a Winter Session Housing Agreement to retain access to their assigned campus housing. Housing and dining charges will be applied.

Students who need extended housing either at the end of the spring semester or prior to the start of the fall semester must submit an Interim housing request form. Requests will be reviewed and approved for limited and specific reasons only. Students approved for extended housing will be charged an interim housing fee.

IV. HOUSING FEES/REFUNDS

Housing and food service fees are approved by the Council of Trustees and may be changed during the agreement period only by action of the Council of Trustees. Payment of fees must be made according to deadline dates indicated on the billing statement.

Apartment residents are billed a semester utility rate based on an average of utility usage.

Students who wish to cancel their Housing/Food Service Agreement must obtain the written permission of the Office of Housing & Residence Life to be released from all housing and food service obligations. Not using or underutilizing a chosen dining plan during the term of the agreement is not sufficient grounds for a refund request.

The room charge will be refunded in accordance with the PA State System of Higher Education Refund Policy as follows in this illustration of *estimated* weeks in typical semester:

Through "drop period"	100%
Through week 2	80%
Through week 3	60%
Through week 4	50%
Through week 5	40%
After the Fifth Week	No Refund

Dining plan refunds are based on the number of days remaining in the semester or utilization rate, whichever is greater. Students will be charged a \$10 administrative fee to cancel a dining plan.

V. FOOD SERVICE

All Commonwealth University - Bloomsburg students are eligible to purchase a dining plan. All residence hall/suite-style students are required to purchase a dining plan. Residence hall/suite-style students must choose either Plan A (19 meals per week), Plan B (14 meals per week), Plan C (10 meals per week), or Plan E 175 Block (175 meals per semester), all of which include FLEX dollars (a declining balance fund for food purchases from the campus dining provider). **Traditional meal plans allow students to eat up to six meals per day (one meal per transaction), up to the number of meals available per week based on the meal plan chosen.** Block meal plans allow students to eat up to six meals per day (one meal per transaction), up to the number of meals available per semester based on the meal plan chosen. See <u>Dining Services</u> for full dining plan details.

Students living in apartments or residing off campus are offered the option of purchasing any available dining plan. They may choose from the dining plans listed above or Plan D (5 meals per week), Plan F 75 Block (75 meals per semester) or a FLEX only plan.

The dining plan chosen in the fall will automatically be reassigned for the spring semester unless the student chooses to change the dining plan during the defined dates. FLEX balances carry

forward from the fall to spring semesters. Any remaining balance of FLEX at the end of the spring semester is forfeited.

Students who wish to cancel their Housing/Food Service Agreement must obtain the written permission of the Office of Housing & Residence Life to be released from all housing and food service obligations. Not using or underutilizing a chosen dining plan during the term of the agreement is not sufficient grounds for a refund request.

VI. ROOM ASSIGNMENTS

Commonwealth University - Bloomsburg recognizes and appreciates the educational value of diversity and does not accept differing backgrounds, races, or religions to be acceptable grounds for honoring room change requests. Every effort is made to honor the student's preference to the extent possible. Failure to honor room preferences will not void this agreement. While housing assignments are generally made between students of the same gender, gender inclusive housing assignments are available by request. With our responsibilities and commitment assured, housing matches are based on responses to the personal information questions in MyHousing.

The university will make room assignments in accordance with the Americans with Disabilities Act of 1990, as amended, and the Rehabilitation Act of 1973. The university will make every reasonable effort to provide equality of opportunity and freedom from discrimination for all members of the university community and visitors to the university. Consistent with the commitment to maintaining an environment of dignity and respect, also house students that are free from all forms of harassment and discrimination, whether because of race, color, religion, sex, sexual orientation, gender identity, age, national origin, ancestry, disability, veteran status, content observed on social media, or any other characteristic protected by law. Students are assured that the accommodations will be provided in a non-discriminatory manner, be comparable, convenient, and accessible, and will be at or less than the cost assigned to other students. Students who receive housing accommodations as the result of a disability will not be subject to additional fees that may be associated with such amenities when they are provided to students who are not disabled.

Current residents must participate in the returning student housing selection process to reserve housing for the following fall/spring. Residents will be given the opportunity to select rooms/suites/apartments for fall/spring by agreeing to the terms and conditions of the housing agreement in MyHousing and following the procedure published and posted by the Office of Housing & Residence Life.

New students must pay an admission deposit which includes reserving space in a residence hall/suite/campus apartment. All students are required to live on campus for their first four semesters (not including summer and winter sessions) unless they are over 21 years of age or are commuting from the home of their parent(s) or legal guardian(s) within approved commutable distance from campus. Students must complete MyHousing when instructed by the Office of Housing & Residence Life to secure their space on-campus.

New students are not eligible to select their housing type or location. The majority of new students are assigned to coed side-by-side housing as this is the most common and preferred type of housing available.

Gender inclusive living is available on the ground floor of Lycoming Hall, 2nd floor of Northumberland Hall, Soltz Hall suites, and in Montgomery Place, Mt. Olympus, and Jessica S. Kozloff Apartments. To *request* placement on a gender inclusive or single gender wing email <u>buhouse@bloomu.edu</u> no later than January 1. Requests will be accommodated as space permits.

Students with disabilities must coordinate with University Disability Services to receive accommodations, in compliance with the Rehabilitation Act of 1973, the Americans with Disabilities Act, and other applicable laws.

Special Housing Accommodations

Students with special housing accommodation requests must submit the Special Housing Accommodations Request form found online at <u>Forms and Policies</u>. Depending on the nature of your request, you may be referred to University Disability Services to provide documentation

from your physician stating your specific housing request and reason/need for this request. They will review those materials and make a recommendation to our office of how best to meet your needs. All residential rooms have air conditioning (either with central air or wall-mounted or window units). Do not submit a Special Housing Accommodation Request for air conditioning.

 Requests received after the deadline will be accommodated ONLY if there are rooms or spaces available. This means roommate requests, learning community participation, or other housing accommodations may be disrupted to fulfill a request.

Air-Conditioned Rooms

All campus residential rooms, suites, and apartments have air conditioning (either with central air, or a wall-mounted or window air conditioner). The wall-mounted units will be turned on at the beginning of each semester and will remain on throughout the semester. The window units have been permanently installed to reasonably withstand winter temperatures and will not be removed at any time.

The Office of Housing & Residence Life reserves the right to adjust housing assignments for the purpose of meeting Americans with Disabilities Act requirements, conducting research, alleviating managerial problems, coping with unexpected fluctuations in the male/female ratio on campus or demand for housing, to consolidate vacancies by requiring residents to move when necessary, to assign a new room/suite/apartment mate and to show the room/suite/apartment. Further, the university reserves the right to reassign or remove any student who refuses to consolidate, or for judicial or administrative purposes.

Unauthorized room/suite/apartment changes are not permitted. Any student who changes an assignment without receiving prior permission from their Graduate Hall Director or from the Office of Housing & Residence Life will be charged \$50.00. The student may also be required to return to the room they vacated without permission and will be referred to the Dean of Students Office.

VII.CONSOLIDATION OF ROOMS

The university reserves the right at any time to consolidate rooms/suites/apartments with vacancies. If a vacancy occurs in your room/suite/apartment, the university will assign someone to that vacancy or you will be reassigned to an existing vacancy at the university's discretion prior to, or at the beginning of the semester.

Students who find themselves without a roommate throughout the semester may, **IF SPACE PERMITS AND IF APPROVED BY THE OFFICE OF HOUSING & RESIDENCE LIFE**, retain the room as a single by paying the established rate for the vacant bed(s) for the remainder of this agreement, or until the student accepts a roommate. Students may not request their room as a single upon assignment of a roommate. Hall staff will attempt to notify residents of a new roommate in advance whenever possible. There is no option to keep a room as a single in the event other students are housed in tripled or temporary housing. If a request to keep the room as a single is approved, all university provided furniture will remain in the room.

NOTE: If a student declines the request to consolidate or to accept another roommate, the student will be charged the established rate for the vacant bed(s) for the remainder of this agreement, or until the student accepts a roommate.

VIII. CABLE TV SERVICE

Basic Cable service and monthly charges are included in the semester room/suite/apartment charge. The University uses a satellite provider and encodes the cable signal. Most modern TVs have a compatible QAM tuner installed in them that work with our service provider. The University cannot ensure your TV make or model will work on our campus. Please see the Housing & Residence Life website for more information on the system and what brands/models of TVs are known to not work. Certain premium channels are also included in the TV package, but are subject to change or cancellation based upon the service provider's contract.

IX. WIFI

All residence halls and upper campus apartments have high speed wireless only connections. All devices connected to the wireless network must be registered through the prompts provided when connecting to the wireless network. All Ethernet connections and network jacks are dormant. Not all living spaces have Ethernet jacks installed. In places that do, and if you prefer a wired connection, submit a Wired Connection Request form found online at <u>Forms and Policies</u>. A wired connection will be re-established, if possible, for you but will come with a charge. Or you may opt to purchase and install a wireless adapter (wireless network card) for your desktop computer.

X. CARE AND USE OF RESIDENCE HALL/SUITE/APARTMENT ROOMS AND FACILITIES

University, residence hall/suite/apartment regulations are listed in the Code of Conduct and the Guide to Campus Living. Violations of any of these regulations may lead to housing reassignment, serious disciplinary action, termination of the housing agreement, suspension, expulsion, and/or arrest.

- 1. <u>Student Room/Suite/Apartment Responsibility</u> Resident students are responsible for their own conduct and that of their guests. Each resident is responsible for his/her own room/suite/apartment, the contents therein, and any activities that take place in the room/suite/apartment. They are also responsible for cleaning their rooms/suites/apartments.
 - We strongly encourage students to take home any items that could be damaged by excessive water, heat or cold over breaks when the residence halls, suites, or apartments are closed. No items should be left on the floor of a residence hall room, suite, or apartment over breaks. In the event of a water line break, items left on the floor and damaged by water will not be replaced at the expense of the university. We highly encourage students to have insurance coverage or purchase PERSONAL PROPERTY INSURANCE at www.nssi.com.
- <u>Damages</u> Students will be subject to payment for damages to the room/suite/apartment and/or
 its contents. Damages to public areas may be assessed to residents of a building or any of its
 subdivisions.
- 3. Room Furniture Furniture may not be removed from a student's room/suite/apartment without permission from the Graduate Hall Director. Students can request to have beds bunked by our staff only. Students may not take apart or alter beds or convert beds to bunks themselves. Lofts, waterbeds and other water filled furniture and non-university bunk beds are prohibited. Students are not permitted to mount anything to walls or ceilings.
- 4. <u>Abandoned Property</u> The University reserves the right, without further notice, to remove personal belongings of, or used by, student(s) that remain in a residence hall room, suite, or campus apartment or elsewhere in the area 48 hours after the termination of the agreement for any reason (withdrawal, academic dismissal, housing revocation, etc...). The University may dispose of any property 15 days after the student(s) vacates campus housing. The student(s) will be charged for expenses incurred in the disposal of such property.
- 5. <u>Visitation Policy</u> The Visitation Policy for students living in Commonwealth University Bloomsburg residence halls/suites/apartments has been developed in an effort to balance student privileges with academic demands and the rights of occupants not hosting a guest. It should be noted that visitation on CU's campus is a privilege, not a right. Students violating this privilege or the rights of others may be subject to the loss of some or all visitation privileges up to the loss of campus housing.
 - Visitation for non-hall residents and non-student guests Monday Thursday is from 10am
 1am. THERE ARE NO OVERNIGHT GUESTS PERMITTED DURING THIS TIME.
 - A 24-hour visitation period begins on Friday morning at 10am and extends until Sunday night/Monday morning at 1am. All non-student guests need to be registered in advance of their arrival. Hosting students may have extended visitors on no more than 2 weekends per month and prior consent among roommate(s) to host a visitor.
 - Residents of the hall/suite/apartment have a 24 hour/7day per week visitation policy within their own hall/suite/apartment. This policy does not extend to visiting other halls in which they do not reside. Do not confuse visitation for 24-hour visitation.

- All student visitors to a residence hall/suite/apartment where they do not reside must gain
 access from a host of the building. All non-student visitors/guests must be escorted while
 in the hall by a University host.
- All weekend visitation guests must be signed in/recorded 24 hours in advance of their arrival through the Overnight Guest Registration form found online at <u>Forms and Policies</u>.
 Failure to do so will result in disciplinary action, the outcome of which can include loss of visitation privileges for a designated period of time.
- It is expected that residents will follow all visitation policies. Failure to comply with any part of the visitation policy by the host/violator will result in sanctioning through the university judicial system and may be subject to the loss of visitation privileges. Hosts are always responsible for the actions of his/her guest(s).
- All visitations within a student's room must have prior knowledge and consent by all
 occupants of the room. Occupant(s) of the room not hosting the guest will in all cases
 have the right to refuse any guest to the room. It is highly recommended that roommates
 discuss in advance what their visitation agreement for their room will be. Staff will assist
 roommates during the first week of school on the rights/privileges and limitations related
 to campus visitation and appropriate behavior when hosting guests. These guidelines will
 be used when completing a Roommate Agreement.
- The Office of Housing & Residence Life reserves the right to amend the visitation policy at any time (i.e. COVID, weather emergencies, or safety concerns).
- 6. Room/Suite/Apartment Inspection/Searches University officials reserve the right to enter a student room/suite/apartment in the interests of the welfare of the individual or the institution for the performance of maintenance, or the enforcement of university regulations. Except under extreme emergency circumstances, premises occupied by students and the personal possessions of students therein shall not be searched unless the appropriate authorization from university officials is obtained.
- Room/Suite/Apartment Safety Inspections Safety inspections will be announced and performed each semester. It is preferred that the occupants be present at the time of the safety inspection however the inspection will occur with or without the occupants present.
- 8. <u>Electrical Appliances</u> The operation and maintenance of electrical appliances are the full responsibility of the student.
 - <u>Refrigerators</u>: All traditional residence hall rooms on lower campus will have a University provided MicroFridge®, with the exception of Soltz Hall. As a result, students are not permitted to bring their own personal refrigerator / MicroFridge® when living in a traditional residence hall. Students living in suites and on-campus apartments may have a personal refrigerator / MicroFridge® in their room if they so choose provided it is no larger than 3.0 cubic feet and uses no more than 120 volts of electricity when running. The Office of Housing & Residence Life is not responsible for any food that spoils due to an electrical outage causing a personal refrigerator malfunction or any malfunction in a university supplied refrigerator in a campus apartment.
 - <u>Televisions</u>: Power Input 120 volts. Students must provide television cable cord. All apartments in MPA are provided a flat screen television in the living room.
 - Use of other electrical/electronic devices such as DVDs, hair dryers and personal computers are permitted, providing such devices are plugged within the room and do not exceed the amperage limits of the circuits within the room. All electrical appliances must be kept in good working condition and are subject to inspection by university employees. The university also reserves the right to confiscate unauthorized or dangerous electrical appliances. EXTENSION CORDS OR MULTI-PLUGS, WITHOUT AN INTERNAL CIRCUIT, AND HALOGEN LIGHTS ARE NOT PERMITTED. Electrical cords are not permitted to be run under carpets. MICROWAVE OVENS ARE ONLY PERMITTED IN SOLTZ HALL and CAMPUS APARTMENTS. For further information, please refer to the Guide to Campus Living.
- 9. Food Storage and Preparation Fire safety requirements prohibit cooking in student rooms (except for MicroFridges). Cooking must be done in kitchen areas or other designated areas if provided. Residents who store food in their rooms do so at their own risk. All food must be kept in tightly closed containers and must be removed during periods when the residence halls are closed to ensure effective pest control.
- 10. <u>Extermination</u> If the University needs to exterminate bugs, fleas, ants, etc. in any room, suite, or apartment for any reason, students are required to follow the Facilities Services

Supervisor and the exterminator's rules regarding the timing, cleaning and/or removal of personal items, and any follow up instructions. Failure to do so could result in disciplinary action, and/or cancellation of your contract and subsequent removal from campus housing. University officials will inspect all apartments once each semester to ensure that health and sanitation standards are being maintained. Students will be advised as to the time of inspections.

- 11. <u>Animals</u> No animals or pets, including laboratory specimens, are permitted in the residence halls/suites/apartments except for fish in a 15-gallon or less tank. Students found with animals in rooms/suites/apartments may have disciplinary action taken and/or cancellation of their contract and subsequent removal from campus housing. Service or emotional support animals are approved only upon coordination with University Disability Services and the Office of Housing & Residence Life. Students who need a service or emotional support animal in their on-campus residence must contact University Disability Services (UDS) for information on the required documentation and approval process.
- 12. <u>Weightlifting</u> Weightlifting equipment is not permitted in residential facilities (ex. barbells, free weights, pull-up bars, large equipment, etc...).
- 13. <u>Sales/Solicitation/Commercial Activity</u> Solicitors and tradesmen, including students and employees assuming an entrepreneurial role, are prohibited from entering the grounds for the purpose of transacting business with members of the university community. See the <u>Guide to Campus Living</u> for more details.
- 14. All residence hall, suite, and apartment facilities are non-smoking.

XI. FIRE SAFETY

Since the potential danger posed to the residential community by fire is so severe, any resident identified as igniting any facility, furnishings, equipment, interfering with fire officials, interfering or tampering with a fire alarm system or safety equipment or placing false alarms will be subject to arrest, fines, and/or disciplinary action as well as termination of the Housing Agreement. All residents are required to participate in fire drills. Evacuation of the building by all residents is required immediately after the fire alarm sounds. Failure to evacuate will result in fines and disciplinary action.

The storage of explosive or flammable substances within any residence hall/suite/apartment is strictly prohibited. In addition, the use of other flaming articles, including incense and candles is prohibited. The transfer, use, or possession of explosives, fireworks, firearms, dangerous chemicals, or any lethal weapons on university property is prohibited. Campus students must register hunting equipment for storage in the University Police Office. This includes firearms, ammunition, knives, and arrows related to such equipment. The use of an outdoor grill is permitted in designated areas only. Grills must never be left unattended. Grills must not be stored inside any residence hall, suite, or apartment.

XII. SAFETY AND SECURITY

All residence halls are locked 24 hours a day, 7 days a week. Residential students must carry their university ID card to gain access into their residence hall/room. Residents are encouraged to keep their room door locked at all times. Visitation procedures will be in effect for individual halls to maintain safety and security. All non-residents and guests must call their host to gain entrance. Guests must be registered with Residence Life and escorted at all times and may only enter and exit through the main doors of the hall. Failure to comply with visitation procedures will result in disciplinary action as outlined in the Student Code of Conduct.

Apartment residents should also carry their university ID card at all times. Front doors to apartments and individual bedrooms (MPA, MOA, JKA) in apartments and Soltz Hall suites are controlled by card access. Soltz Hall, MPA, MOA, and JKA residents are encouraged to keep their bedroom doors locked at all times.

XIII. **LIABILITY**

The university assumes no LEGAL RESPONSIBILITY for accidents or injuries incurred by students falling from beds or ladders in rooms where they have chosen to bunk their beds.

Bedrails are standard and installed on all bunked as an added safety feature for our students. They are inventoried into the room and must be present and in use while there are bunked beds in use in the room. We feel very strongly about the added safety the bed rails provide in the prevention of falls. Bed rails must remain on the beds and we highly recommend that you do not remove them. Students will not incur a charge for removing bedrails however, a replacement fee of \$53 per bedrail will result for any missing or damaged bedrails.

The university assumes no LEGAL RESPONSIBILITY for the loss of or damage to personal property due to insufficient or excessive heat, fire, smoke, water, the elements, or actions of third persons. Therefore, students are strongly encouraged to take computers, TVs, and other electronic devices, etc. home over semester breaks to avoid potential damage. Residents should carry insurance protection for their personal belongings.

XIV. TERMINATION

The university may terminate the Housing/Food Service Agreement for violations of any of the provisions herein, for violations of university regulations, residence hall/suite/apartment rules and regulations, health, or for any other reason deemed sufficient by university officials. Resident students whose agreements are terminated for any reason (withdrawal, academic dismissal, housing revocation, etc...) must vacate their rooms/suites/apartments within 48 hours of notification.

Loss of housing could result if Housing & Residence Life staff determine that an individual's behavior is detrimental, disruptive or disorderly to community living.

THE EXECUTION OF THIS AGREEMENT REQUIRES THAT BEFORE REGISTRATION, THE STUDENT MUST HAVE SATISFIED ALL OUTSTANDING OBLIGATIONS TO THE UNIVERSITY FROM PRIOR PERIODS OF ATTENDANCE INCLUDING BASIC ADMISSIONS, HOUSING, AND FOOD SERVICE FEES.
