- Linda has a list of FAQ's for the website for Angela so far
- Mykola suggested adding topics to choose on feedback form to help separate information when it comes in
- Have "other" column as well and capping the # of words that can be used

- Angela is working on changing documents from PDF's into HTML



B. Geasar Collection and Analysis

John Riley has showed the transfer language for GEP's to the campus community with mixed reviews. It was suggested doing a pro's and con's list with a column that states if each can be achieved somehow. Amy Wenta stated the 99 courses only make up about 30% of the transfers that get added in.



Additional Language Document

Angela discussed the Program to Program transfers and where this is written in policy. She reviewed years of BUCC meeting minutes and discovered that it was presented, discussed and a recommendation was made to amend PRP3343 but to first discuss with the Provost. Then it was mentioned a year later in notes as to what was going on and nothing in the past several years. Mark Bauman said according to the Registrar's Office this is in a memo from 2014.

It is noteworthy that the added email/feedback feature on the website began with the OPA Summer GE Fellows and progressed with the help of Linda Neyer, Judy Ohl, and Angela La Valley. By adding this section to the website the goal was achieved to

provide a means for communicating GE ideas especially since non-member attendance and comments have been largely inactive.

B. GESAR Collection and Analysis

Angela stated a reminder email has been sent in regards to the GESAR collection. She also spoke to three department chairs that are working on turning in information for 4, 5, and 6. There are chairs that have asked for extensions to turn in for goals 7 through 10. She has agreed to extend the collection through the beginning of next semester to all for better feedback and the GEC agreed. Per Jerrold Harris goals 7 through 10 have 14 responses so far.

5. PRP 3343

Mindi gave an update on PRP 3343 which was brought up in discussion at the most recent BUCC meeting. Bill Hudon gave some language in regards to this topic to BUCC. Public Health Nursing (with clinical similar to internship) was mentioned that carries 2 GEP's for citizenship. Nonetheless, no GEP's for BIO 298 were approved.

The concern seemed to be that this would keep the student from going outside their department for GEP's. Angela stated further discussion with data is needed. Sheila Jones provided insight related to students getting GEP's outside or inside the major and that BOG and SEP have guidelines for helping students finish within the 120 credit and 4-year timeframe. It was mentioned that either BUCC members should be invited to discuss or GEC should take the discussion to BUCC and present. Angela will discuss with Dr. Riley.

1. Approval of the Agenda of March 5, 2018

Loren Selznick moved to approve the agenda. Mykola Polyuha seconded the motion.

Motion to approve the agenda passed by voice vote.

2. Study Abroad:

Nawal Bonomo stated that GEPs are a problem for study abroad students. Several commented that a Petition for Exception form should be used which would then pass through the Student Advisor, the Department Chair, and then on to the Dean to approve. The transfer credit issue is currently being worked on and revisions may result in the Petition form no longer being necessary.

3. Transfers/99 Courses:

Mark Bauman stated a large group (Dept. Chairs, Registrar Office, GEC BUCC, and Provost) met on 2/23 to talk about the transfer policy for about 4 hours. Revisions are still being worked on and the document is not ready to be sent out at this time. The Registrar's Office stated that a policy for Program to Program students needs to be in place with the information publicly available.

In regards to 99 courses, it was stated that when the study abroad students return it is the responsibility of the chair/advisor to look at this for those students. The students should not be denied the experience because the study abroad course does not align.

Dee Wymer stated that the General Education Program is not working for study abroad students.

The dilemma is that there is so much work involved around courses at BU that approving courses that are outside the system can cause an even bigger issue.

4. General Education Discussion:

Linda Neyer stated there were a lot of good remarks regarding General Education at the Chairs meeting.

COLA members stated that students are no longer taking classes if there are no GEPs attached and enrollment has gone down. Many said the system doesn't encourage the students to go outside of their college or discipline to meet the requirements creating a narrowing of General Education. Molly Marnella stated we have to remember that student population changes as well. Wendy Lee stated that students are not meeting with their advisors to receive advice on which courses would be best for them to take.

Molly Marnella stated a taskforce should be formed to compare the systems at other institutions to see if their systems truly are better than our General Education Program. Or, are they having the same problems.

Dee Wymer stated that another difficulty is that each committee tells you something different to do on the proposal and there is too much inconsistency between the committees. Mike McFarland added that discussing ground rules with all the committees could make it an easier process.

Wendy Lee stated the program as it is now hurts the crafting of courses and causes faculty to write the courses in specific ways to get the points and causes faculty to game the system. She stated that suggestions were given to alter the old program but that their ideas fell on deaf ears. It was also stated that the system was broken and should be rebuilt from scratch.

Linda Neyer suggested people view the General Education Program Archives file (S Drive>BU Document>GEC) to find past faculty surveys, emails, blog posts, etc. on the development of the new GE program from the period 2007-2011.

Margaret O'Connor added that departments should want the students to have options of what they actually want to study. She then asked the question "How do you facilitate/cross communicate amongst the colleges to get this done? Instead of going to a negative place."

Kara Schultz added that perhaps a software program would help advisors calculate what is needed for each student instead of a manual calculation. She added the score card does help, but the advisor needs to go back and check it to make sure the class was actually passed. The score card only shows enrolled courses and not completed/passed courses.

Bob Heckrote added that degree audits help. He stated he has met with many students because they cannot get with their advisors and many are unsatisfied. He stated he uses two spreadsheets to calculate what a student needs and that it is actually a fairly easy process.

5. Assessment:

Tina Entzminger stated that the process was forced on the departments by higher administration and not Middle States. Mark Bauman stated that Middle States wants the university to have this conversation.

Concerns were offered about the burden of assessment – that the assessment process is labor intensive and disconnected from the work done. There is uncertainty that we are doing "meaningful" assessment to improve the quality of what we are doing.

Bill Hudon stated that assessment is supposed to be by program not by the course. By doing so, it is assessment of the faculty member teaching the course, which the union contract states cannot be done. He also stated that the system causes faculty to work from the top down instead of the ground up.

Mindi Miller pointed out that Middle States standards ask for periodic assessment. She added the Value Rubric and data has worked in some areas but not others.

A suggestion was given that only doing a sampling of courses could maybe simplify the data and make it more useful. Pick several foundational courses that everyone needs to take and then branch out from there.

Dee Wymer suggested taking a look at SUNY Geneseo College as they have a great outcomes assessment.

Dr. Krause appreciated everyone's input and stated it helps create an opportunity to make the system better.
